<u>Notice of Organizational Restructuring of Group Companies</u> (Business Transfer and Merger among Consolidated Subsidiaries)

Meitec Corporation decided to undertake an organizational restructuring of its engineering solutions Group companies (business transfer and merger among consolidated subsidiaries), as follows.

1. Content of the Organizational Restructuring of Group Companies

The Meitec Group's objective is to improve service to customers through restructuring and integration of the electronics device development and printed circuit board-related business in its engineering solutions business, which is currently being conducted by several companies. A business division of Meitec's consolidated subsidiary Information Management System will be transferred to its consolidated subsidiary Meitec Global Solutions, after which Information Management System will be merged with Meitec's consolidated subsidiary Apollo Giken, with Apollo Giken as the surviving company.

Because the business transfer and merger will be conducted among consolidated subsidiaries of Meitec, no change will be made to consolidated forecasts for the fiscal year to March 2008 as a result of this transfer and merger.

2. Business Transfer

1) Content of the Business Transfer

To enhance the solutions function of the Meitec Group, the Circuit Board Solutions business department run by Meitec's consolidated subsidiary Information Management System will be transferred to its consolidated subsidiary Meitec Global Solutions.

3. Merger

1) Content of the Merger

To enhance the solutions function of the Meitec Group, the consolidated subsidiaries Apollo Giken and Information Management System will be merged, with Apollo Giken the surviving company and Information Management System dissolved.
